### WARRANTY

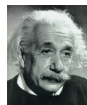

- ✓ The fee covers...

- Preparation of Federal and State income tax returns and estimated payment vouchers (if required) at the time the returns are prepared.
- General questions about how your tax returns were prepared, including...
- **Year-round** telephone & email consultations concerning the prepared returns.

- ✓ Additional Charges... the Income Tax Preparation fee does *not* include: bookkeeping, revised or initial estimated payment vouchers prepared after the returns have been filed; re-doing the returns when the client presents additional information after the returns had been completed; tax research; tax advice; tax audit representation; or specific preparation for an audit. General questions about your return, such as how a deduction was arrived at, will be answered at no additional charge.

## Tax Questions & Tax Problems

- ✓ There are **no additional charges** for most simple tax questions or problems; more complicated tax problems will be subject to an additional charge.

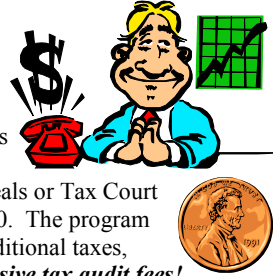
## ... TAX PLANNING ...

- ✓ The tax planning fee is in addition to the charge for preparation of your Federal and State Income Tax Returns. It covers optional income tax and financial planning services.

## 1040-TAX NOTICE & AUDIT PROGRAM

- ✓ Our **1040-TAX NOTICE & AUDIT PROGRAM** covers the answering of tax notices and audit representation on your behalf at **NO ADDITIONAL CHARGE!** This program enables you to avoid having to deal with IRS or State Taxing Authority notices, or having to meet or speak with an IRS Agent or State Tax Auditor. Any TAX NOTICE received or TAX AUDIT conducted during the next **3 years**, as it relates to the preparation of this year's individual form 1040 tax returns (Federal or State), will be covered (business returns are not included). Tax audit representation is at the agent level only... not Appeals or Tax Court representation. All representation shall generally take place during the off season... May 1 - November 30. The program does not include bookkeeping or specific preparation for an audit and the client is responsible for any additional taxes, interest, or penalties resulting from an audit. *Avoid the additional costs to answer tax notices and expensive tax audit fees!*
